**Grant of Financial Assistance (F.A) to ESM of pre-independence era (World War-II veterans) i.e. ESM enrolled before 31<sup>st</sup> August, 1945 & their widows, who are not in receipt of any kind of pension/financial assistance.**

2. The State Government has decided to increase the rates of Financial Assistance to ESM of pre-independence era (World War-II veterans) i.e. ESM enrolled before 31<sup>st</sup> August, 1945 & their widows, who are not in receipt of any kind of pension/financial Assistance from Rs. 4500/- per month to Rs. 10000/- per month w.e.f 01.11.2017.
3. All other terms and conditions for grant of Financial Assistance (F.A) to ESM of pre-independence era (World War-II veterans) i.e. ESM enrolled before 31<sup>st</sup> August, 1945 & their widows, who are not in receipt of any kind of pension /financial assistance, will remain unchanged.
4. The expenditure will be debited to Major Head "P-01-22-2235-60-200-(96 & 97)-51-34 Other Charges" FA to ESM & Widows of ESM of pre-independence era (World-War-II).
5. THESE INSTRUCTIONS WILL COME INTO FORCE FROM 01.11.2017.
